Introduction

Purpose

The purpose of the boundary review is to create new school boundaries to accommodate the opening of Dr. Robert Plaxton Elementary School. This review will require a review of most of the elementary school boundaries.

Programming changes are also reviewed due to recommendations from the West Lethbridge Boundary Review Committee to alleviate growth pressures at elementary and high school in West Lethbridge. These changes involve moving French Immersion from École Nicholas Sheran, back to École Agnes Davidson. At High School, Lethbridge Collegiate Institute Boundaries will be impacted due to recommendations to move some students from Chinook High School to LCI over a four-year period.

Boundary Review Committee

To ensure that the review takes into consideration a number of factors and perspectives, the committee is comprised of members from schools that will be most impacted by a proposed change to school boundaries. Involvement of these stakeholders at the beginning is important to the process of reviewing growth, capacity and programming challenges in South Lethbridge. The members of the committee include:

Considerations for the Boundary Review



The Boundary Review Committees consider a variety of factors when considering boundary changes, such as the following:

- Existing and proposed boundaries
- Enrolment projections (5 or 10 years as appropriate)
- Future residential growth potential
- o Number of students impacted by the boundary change
- o Implications for program delivery (specialty programs, class size, structure)
- Community based boundaries vs program boundaries
- Grade configuration
- Facility utilization
- o Transportation considerations
- Capital implications (modular classrooms, new construction, Infrastructure Maintenance and Renewal)

Enrolment and Capacity challenges

Facility Capacity


To address facility capacity concerns in South Lethbridge, a new school, Dr. Robert Plaxton Elementary, is currently under construction in the developing community of Southbrook. The construction of this school is designed to alleviate growth pressures at Lakeview and École Agnes Davidson Schools. Before the addition of Dr. Robert Plaxton, École Agnes Davidson and Lakeview have core capacity of **124%** and **115%** respectively. Lakeview, which is impacted the most by the addition of the new school, has a capacity of **91%**. Core capacity is the capacity of the school taking out modular classrooms that have been added to address growth pressures. High core capacity indicates stress on core areas of the school such as gymnasiums, Learning Commons and gathering spaces.




Enrolment Growth


The charts below show anticipated enrolment growth over the next 15 years. South Lethbridge elementary, middle, and high schools.

Although growth at elementary schools is relatively flat in the chart below, the chart does not reflect the new growth area of Southbrook.




Gilbert Paterson Middle School is expected to grow in enrolment then level out to reflect current enrolment. Gilbert Paterson is also the French Immersion Middle School for the City. LCI is expected to grow in enrolment over the projection period. However, LCI has significant excess capacity to address future growth.



Enrolling in new proposed boundaries

Enrolment in new school boundaries will take **effect for the 2021-2022 school year**. There will be strict adherence for students to attend the new established boundaries to address facility capacity and enrolment growth pressures.

The School Division will continue to follow *Policy 501.3.1 School Choice* that allows for fair and just consideration of requests made to have students enrolled in a school outside of their attendance area. Decisions will be based on the following criteria, including:

- Availability of space;
- Educational considerations, including class composition;
- Projected enrolment for the school;
- Suitability of school programs and services for that student;
- Students priority of enrolment (as per regulation 4 of the policy); and
- Additional costs to the school and/or Division.

Transportation Impacts

Elementary Schools

Where some École Agnes Davidson students that are south of Scenic Drive do not require bussing to École Agnes Davidson, they may require bussing to Dr. Robert Plaxton. This cost of bussing should be offset by some students attending Lakeview school south of 24th avenue that will no longer require bussing to attend Dr. Plaxton school. It is anticipated that the cost impact to transportation will be minimal.

Middle School No change

High School

Assuming all students ride the school bus from West Lethbridge to LCI, there would need to be transportation to South Lethbridge. Most of the students in the new boundary area would already qualify for transportation. Additional cost of bussing would be related to additional fuel cost to the south side of Lethbridge.









School Boundary Maps – Current




School Boundary Maps – Proposed 2021-2022

Planned community growth




Note: École Agnes Davidson boundaries will be coterminous with the City.



Dr. Robert Plaxton Elementary School

This new elementary school in the community of Southbrook will have a boundary that is all areas south of Scenic Drive and 24th Ave and to the east and west of Mayor Magrath Drive S.



École Agnes Davidson French Immersion

As recommended by the West Lethbridge Boundary Review, École Agnes Davidson will become a French Immersion school with no English programming. Current English program students will go to Lakeview Elementary except for students that are south of Scenic Drive that will go to Dr. Plaxton.

The new boundary will be coterminous with the City of Lethbridge.







Lakeview Elementary School

Students attending the Agnes Davidson English program north of Scenic Drive will now be part of the Lakeview Elementary boundary.

The shared area with Fleetwood will now belong to Fleetwood only.







Middle School - Proposed

No change to Gilbert Paterson boundary. Gilbert Paterson will be the middle school for South Lethbridge and French Immersion Middle School for the entire City.



• LCI's boundary will be South Lethbridge plus part of the south end of West Lethbridge, which includes students that reside south of Temple Blvd W, communities of Riverstone, Canyons, Sunridge and future growth area of Watermark.

Feedback will be accepted until January 28th, 2021. The feedback will be provided to the Board of Trustees in early February. The Board will review the feedback and the proposed boundaries will be provided for consideration and approval at the February 23rd meeting of the Board of Trustees.

The Division, in anticipation of these questions, has posted a Frequently Asked Questions area on the Boundary Review website. There will also be the opportunity to post additional questions.
